The Court hereby makes the following findings and conclusions:

FINDINGS OF FACT

1. According to RCW 64.38.010, "homeowners' association" is defined as follows: "a corporation, unincorporated association, or other legal entity, each member of which is an owner of residential real property located within the association's jurisdiction, as described in the governing documents, and by virtue of membership or ownership of property is obligated to pay real property taxes, insurance premiums, maintenance costs, or for improvement of real property other than that which is owned by the member."

- 2. RCW 64.38.015 states: "The membership of an association at all times shall consist exclusively of the owners of all real property over which the association has jurisdiction, both developed and undeveloped.
- 3. The Admiral's Cove Bylaws allow for Associate Members, which, according to the Bylaws shall be persons who are, on an annual basis, elected upon such terms, both as to dues and assessments, as the Board of Directors shall determine. Associate Members cannot exceed 250 in number. Associate Members do not own property in Admiral's Cove development, however, Associate Members are allowed privileges upon payment of an assessment.
 - 4. Associate Members are members of Admiral's Cove Beach Club.
- 5. Given that Admiral's Cove allows for members that are not real property owners, it is not a homeowners' association pursuant to RCW 64.38 et seq.

Now therefore, it is hereby ORDERED:

- Defendant's motion for summary judgment is hereby DENIED and Plaintiff's cross-motion for summary judgment is hereby GRANTED; and
- 2. There are no remaining issues to be resolved in this action; this matter is hereby concluded.
