UNFINISHED BUSINESS

<u>Bluff pipe</u>: none of the bluff property owners have taken advantage of the free pipe made available through the Club's efforts. Kurt has copies of all correspondence and emails sent to Farragut owners/Members regarding Club efforts and suggestions to minimize the possibility of further sloughing on the bluff. There is a utility/drainage easement in favor of the County on the Pritchard property. An email about that will be sent to Phil Cohen, Island County Water Engineer.

Status of strengthening the toe along the ditch and/or clean out On hold until next Spring or Summer

Collection efforts for 2012-2013

An attempt was made to serve by registered mail five Members Not in Good Standing with small claims court filings Three were accepted, two were not. Only one of the three defendants properly served showed up in Small Claims Court on the appointed hearing date. A payment plan of \$50.00 per month was negotiated with that member for delinquent dues and fees. The Sheriff's Office was requested to

serve the two defendants who did not sign for the registered letters, but those attempts by the Sheriff were also unsuccessful.

Because this process is very time consuming. Kurt asked the Board to authorize him to explore turning over collection efforts to outside counsel. Outside council usually has a collection agency – and would act according to collection laws. They also would have affiliates in other counties and states.

Trial has been set in February for the two defendants who were served but failed to appear. Should one of those defendants be in the military, there is nothing we can do. Greg suggested that we could find out who his/her CO is. Mike and Ed suggested we could also check with Legal Services at the Base.

The Board gave unanimous approval for Kurt to check this out.

NEW BUSINESS

Posting of financial packets: Kurt has everything back to beginning of the year and will send to Heather. We need to define a mechanism of how to do a maximum of 2-page Summary sheet. Steve will send Kurt August through December for posting.
