Steve Koblyk:

- 1. Communications... Change committee name to newsletter committee? Concern about lack of communications re: new board members, pool updates, BBQ review. BoD will look into posting more website updates. Make sure we really communicate the heck out of the pool opening!!!
- 2. Maintenance for the pool... Have we hired someone? New equipment will require reduced maintenance. Dennis & Marty have a handle on it and will monitor. - 3. By-laws... What were we going to discuss (from prior months notes)?

- 5. Last month's members forum... Add other subdivisions to ACBC? No additional action has been taken.
- 6. Balance sheet, notes, etc. Tidy up the language regarding fund transfers... add internal transfers, etc.

Doug Fielding:

- 1. Pool is subsidized, always has been, most likely always will be.
- 2. Do we have the county maintenance permit?

Dustin: Add to meeting agenda a discussion to improve communications, update bylaws, opt in, etc. Bob Stiles:

Pool committee report said we need volunteers to rebuild pool fence... Do we need to now round up the volunteers? Set the date? Organized the materials, etc.? Permanent fence necessary to pass inspection. Bob knows someone who can get it done. Dustin asked for contact information and an estimated cost for this project as a 1099 independent contractor. Primarily for his labor. We will have material expenses.
