POOL COMMITTEE - Work party put in the backflow valve conduit; drained systems, installed heat pump covers, all winterized. WMS still has list of things to finish. Will need to wait for spring for concrete work.

BUDGET AND FINANCE -Waiting for one final BoD member vote before distributing final copy and posting on website.

LONG RANGE PLANNING - None. Need a committee for future planning.

COMMUNICATIONS - None.

BYLAWS - no news back from them on the two items we sent to them.

*Meeting with the Navy. They first met w/Marty & Dennis. The Navy doesn't wish to do a community meeting at this time. They then met with the ACBC Government Relations committee. They want to meet again with this group in the future to discuss how to improve communication with our community, with Kurt Blankenship being the primary point of contact. This will be more to benefit the community rather than ACBC.

*Oak Harbor High School Swim Team - They have been invoiced for \$1,500.

NEW BUSINESS

*Site Drawing - No estimate yet from TMI. Have asked again. Need it for any permit that we might need (i.e. trimming, pruning, ditch cleaning, etc.).

*Picnic tables - Suggestion for a picnic table for our lakeside picnic area. Minimal maintenance. Two for the pool, one for the lake. If good product, will buy 8 more for the pool area. ~~Mike made a motion to purchase three tables, Jim seconds, all approved~~. Need four new benches for dressing rooms, will replace in 2019.

*Life guards - Veronica has agreed to be head lifeguard and has two additional candidates. She will take her training certificate and will be able to train other guards, and we could host. ACBC will pay \$400 for Veronica's training and she will agree to host two seasons of training sessions. Multiple opportunities to 'rent' mannequins for CPR training.

*Reserve Study - Need to create/review list of (capital equipment) for inclusion for the reserve study. Dennis, Mike & Marty will set up a meeting a.s.a.p.

*Other - Conversation about treating algae with chemicals (encourages growth such that it chokes itself out) as needed; also discussed a way to use sunlight to control it via a dye.
