BUDGET AND FINANCE:

The Admirals Cove Beach Club Budget Committee is happy to report that our 2020 Annual Operating Budget has been completed and has been sent to the ACBC Board of Directors for their approval. Upon approval, we will strive to operate within our budgeted means and engage in long term planning to meet the needs of our community and beach club members. Our annual community meeting is slated for February 2020 and we hope our members will attend to receive updated information to be given at that time. We look forward to input from our members who might have new ideas and suggestions for the betterment of our community as a whole.

POOL COMMITTEE:

We had a great swim season this year. Because the Camp Casey pool was closed this year, the swim lesson program returned to our pool. We taught 1374 swim lessons this year and with the help of the Coupeville Lions Club paying for our assistant instructors and helping those who could not afford the total cost of the lessons, the swim lesson program broke even. ACBC will continue the swim lesson program in 2020. We also rented the pool to the Sea Cadets for two 2 hr. sessions. Members and their guests using the pool totaled over 3700 this year. Because of the new heat pumps, the cost of heating the pool was less than half of the cost of the propane unit. I would like to thank all the volunteers who helped with the pool operations this year and a special thanks to our 8 lifeguards and 5 assistants who made this year a success.

New posts/basketball hoops in the playground area. Repair of the chain link fence entryway to the pool. Work party dates/times will be posted. BYLAWS COMMITTEE:

The Bylaws Committee met to review, discuss and dialog several suggestions submitted by a Member in Good Standing. The committee decided not to recommend the changes to the Board for consideration and informed the member of the reasons. Nevertheless, any Member in Good Standing is free to propose bylaw changes to the Membership as a whole or to the Board in accordance with the process spelled out in the current Bylaws. Unless such proposals are timely made, it appears at this point that the membership will not be asked to vote on any bylaw changes this year.

The Lake Committee is evaluating methods to reduce pollutants in the lake that foster algae growth and considering improvements to the tide gate and the outfall pipe that drains to Admiralty Bay.
